EXHIBIT ENTRY DEADLINE:

All entries must be set up and ready for judging by the close of set-up time Thursday April 16, 2009. Or, with the approval of the Show Chairman AND Rules Chairman, between 7am and 9am on Friday April 17, 2009. And, they may not be removed prior to the close of the show Sunday, April 19, 2009. All exhibits must be removed by 8pm Sunday.

SECURITY WILL BE FURNISHED. (See non-competitive exhibitor's contract) TWO GUEST PASSES PER EXHIBITOR WILL BE PROVIDED.

Cases will be assigned space on tables approximately 30 inches high. Exhibits are limited to 150 watts of power per case, and exhibitor must supply a three prong extension cord to reach the power supply under the tables. (Approximately 10 feet)
